As per Government Order read as 3rd paper above Government have consituted State Empanelment Committee, State Grievance Redressal Committee and District Grievance Redressal Committee for the smooth functioning at various levels in addition to the Governing Body and Executive Committee. As per the note referred as paper 4 above, the Executive Director, State Health Agency (SHA) has requested to constitute a Claims Review Committee comprising of the following members for addressing the medical merits of the disputed claims raised in the DGRCs.

- District Medical Officer or nominee.
- District Programme Manager, NHM.
- District Project Coordinator, State Health Agency.

Also, as per the GO read as 3rd paper above, District Grievance Nodal Officer acts as the convener of DGRC where it was not specified that the District Project Coordinator of SHA will be the DGNO. Therefore as per the note referred as 4th paper above, the Executive Director, State Health Agency (SHA) has also requested to make clarification in the order that the District Project Coordinator of SHA will also function as the

District Grievance Nodal Officer for the effective functioning of the grievance committees in the District.

Government have examined the matter in detail are pleased to appoint the District Project Coordinator of SHA as the District Grievance Nodal Officer for the effective functioning of the grievance committees in the District and also to form a Claims Review Committee comprising of the following members for addressing the medical merits of the disputed claims raised in the DGRCs.
 - District Medical Officer or nominee.
 - District Programme Manager, NHM.
 - District Project Coordinator, State Health Agency.
