**ORDER**

As per Government Order read as first paper above, Government has constituted a permanent State Health Agency [SHA] to carry out all activities with regard to the implementation of KASP in the State. Later vide GO read as 2nd paper above it was ordered to implement the KASP scheme in an assurance mode where the claim of private hospitals alone will be serviced by a Third party administrator/Implementation support agency. As the Government have decided that the selected TPA/ISA has to outsource the claims of public hospitals as well vide GO read as third paper above the aforesaid order has been modified where the claim of Public/Private Hospitals will be serviced by a Third party administrator/Implementation support agency.

Vide GO mentioned as 4th paper above Sanction was accorded to award the contract to M/s Vidal Health Insurance TPA Private Ltd for servicing the claims of public empanelled



hospitals under AB PMJAY -KASP as per the package rates approved by the Government for a period of one year from 19/01/2021 and allowed processing of pending claims starting from the period from 1<sup>st</sup> July 2020 by the appointed TPA.

As per Government Order read as 5<sup>th</sup> paper above, Government have constituted a permanent High Level Committee for sanctioning extension of service of TPA/ISA in the light of present COVID situation.

As per the Note read as 6th paper above the financial bids of all five eligible bidders were evaluated by the modified evaluation committee constituted vide aforesaid GO and they have recommended to the Government to accept the bid of M/s Vidal Health Insurance TPA private Ltd for servicing the claims of public empanelled hospitals under AB PMJAY-KASP as per the package rates approved by the Government.

Government have examined the matter in detail are pleased to accord sanction to award the contract to M/s Vidal Health Insurance TPA private Ltd., for servicing the claims of public empanelled hospitals under AB PMJAY-KASP as per the package rates approved by the Government for a period of one year from 16/08/2021.
