As per the read above the 4th Executive Committee of State Health Agency Kerala, which was held on 6th June 2022, approved the proposal for hiring a Third Party agency for Conducting Hospital Audits, as a one-time activity for effective implementation and to reduce fraudulent claims under KASP.

Since it is an experiment, the Hospital Audit Agency has been selecting initially for a period of three months audit. It is estimated that, a minimum of three doctors and fourteen nurses, that we expected from the agency and the additional doctors and nurses will enhance the quality of the activity.

Calculation of anticipated expenditure

HR expense (per month) estimated

3 doctors x Rs. 60,000 = Rs. 1,80,000, 14 nurses x Rs. 30,000 = Rs. 4,20,000,
