The Department of Health & Family Welfare, Government of Kerala (GoK) through the State Health Agency, Kerala invites competitive quotations from third party administrators / implementation support agencies who fulfil the eligibility criteria as laid down in the Tender Documents for the implementation of the Ayushman Bharat - Pradhan Mantri Jan Arogya Yojana (AB PM-JAY) – Karunya Arogya Suraksha Padhathi (KASP) and all other schemes run through State Health Agency (SHA) in the 14 Districts of the State of Kerala for servicing the claims of Public Hospitals.
