All relevant documents from the three agencies have been verified in accordance with the above Pre Bid Qualification criteria and informed the attendees that SHA had verified all of their documents and informed that, as Spectrum applied for the exemption of the tender fee as well as EMD, attaching the Udyam Certificate as evidence, SHA should verify the validity of the same and if found invalid, SHA will consider Spectrum Planning India Ltd's tender to be invalid.

It is also informed that SHA will also verify the documents provided in accordance with the Technical qualification criteria by verifying the technical proposal submitted by each agency and whether the minimum 60% technical criteria has been met by each agency, SHA will call agencies for further process, including presentation of the work, and will inform the concerned agencies that who all are eligible for participating in the Technical bid and Technical presentation and the subsequent process of Agency selection.
